NB: Travelling with Children. New Zealand law stipulates that children under 7 while travelling in a vehicle must be properly restrained in an approved child restraint. It is strongly recommended by Land Transport New Zealand that children should be seated in the rear of the car.

The Hirer and the Credit Card holder each acknowledges that he or she has been given the opportunity to read and understand these Terms and Conditions of Hire and the Hirer and the Credit Card holder each agrees to be bound by the Terms and Conditions. The Hirer and the Credit Card holder authorise the Owner to debit any Further Charges against the Credit Card, or to deduct such Further Charges from the bond, as the case may be.
